

Farmers and producers can quickly and easily generate serialized global trade numbers (GTINS) that are used to create GS1 compliance labels while at the same time leveraging RFID technology to create a "digital twin" or "digital identity" of the product. This digital identity allows the product to be traced all the way through to the consumer and is the first step in creating a connected supply chain.

In addition, Avery Dennison is a GS1 "Identity Provider". That means we fully understand GS1 standards and have been granted permission from GS1, through our Freshmarx Connect solution, to help farmers and producers create digital identities for their products and help them determine the how and what is needed to create and apply GS1 compliant labels to their products.

What are GS1 Standards?

GS1 standards are designed to improve the efficiency, safety, and visibility of supply chains across physical and digital channels. They form a business language that identifies, captures, and shares key information about products, locations, assets, and more.

Addresses Key GS1 Compliance Challenges

Typically, farmers and producers face three major challenges in implementing a successful GS1 compliant labeling program: complexity, accuracy, and productivity.



Challenge: Complexity

Like many compliance initiatives, the process for complying with GS1 standards for source labeling has a lot of "moving parts" and it can sometimes be difficult to understand what is being asked of the farmer. Some frequently asked questions include, "How do I use the GS1 data I have and translate that to compliance labeling?" "What's the process for entering shipping and other commissioning events into a transparency provider such as the IBM Food Trust?"


